

## **CONSTITUENCY PROFILE**

### Hurungwe West Constituency



#### Introduction

Mashonaland West is mainly a rural province with a few urban centres (Kadoma, Kariba, Chinhoyi, Norton, Karoi and Chegutu). The Zezuru and Korekore tribes come from this province. Hurungwe West is in Hurungwe RDC which is the most Korekore populated district<sup>1</sup> in Mashonaland West. Former ZANU PF Mashonaland West Chairman, Temba Mliswa for the Member of Parliament for Hurungwe West Constituency. Zanu PF expelled him from the party and his seat was declared vacant by the Speaker in accordance with Section 129 (1) (k) of the Constitution<sup>2</sup>. The President in the Government Gazette proclaimed 10 June 2015 as the date for the by-election.

#### **Population and demographics**

The area comprises Zvipano, Nyamhunga, Masanga, Kares and Chivakanyama. Livelihoods are derived mainly from agriculture. The poverty levels are high, given that the soils are sandy and need a lot of fertilizer, which is inaccessible and far beyond the reach of many. People of Zvipano also derive income from fishing.

Mashonaland Central in 2012 has a population of 1501 656, of which 747 475 were males and 754 181 were females. The ZimStat 2012 Census report states that the population of Hurungwe District constitutes 21.9% of the provincial population. The district has a population of 329 197, of which 164 711 are males and 164 486 are females<sup>3</sup>.

Mashonaland West comprises of 22 national assembly constituencies, 6 senatorial seats and 6 wards (15, 16, 17, 24, 25 and 26)<sup>4</sup>.

#### **Previous Election Results**

Before the delimitation of 2008, the electorate has always voted for ZANU PF and in 2008, the MDC-T won the constituency. There were reports of intimidation and violence in the run up to the 2008 elections. See table below for results of the 2000, 2005, 2008 and 2013 harmonised elections.

#### Background and legal framework

Temba Mliswa was expelled from ZANU PF on February 18, 2015. The expulsion of Mliswa follows a series of allegations on factionalism, insubordination, undermining the authority of party leaders just to mention a few of the accusations. The Constitution of Zimbabwe stipulates that a party has the power to reclaim a seat when a member has been expelled from the party. On 3 March 2015, the Speaker of Parliament announced that Mliswa had been expelled from Parliament following the request by ZANU-PF<sup>7</sup>.

According to Section 129 (1) (k) of the Constitution *"if a member has ceased to belong to the political party of which he or she was member when elected to Parliament, the political party concerned shall write notice to the Speaker or president of the senate declaring that the member has ceased to belong to it" and therefore the seat was declared vacant and a Proclamation by the President set 10 June as the date for the election while 8 April as nomination.* 

#### **Registered voters**

As of the 2008<sup>8</sup> the total registered voters stood at 25,834. In 2013 the registered voters increased to 26 261<sup>9</sup>, representing an increase of 427 voters. From 2008, there was a 1.65% increase in registered voters. Basing on the 2013 19 June voters' roll, anecdotal evidence would point that there was general under registration of the electorate between 2008 and 19 June 2013. These statistics do not incorporate the mobile voter registration exercise that was conducted from June 9 to July 9 2013.

#### **Primary Elections**

ZANU PF conducted primary elections in Hurungwe West in preparation for the byelection. Mashonaland West Vice Chairman Dr. Keith Guzha secured the ticket to represent the party in the Hurungwe West by-election set for 10 June 2015. Affirmative Action Group (AAG) president Keith Guzha won the Zanu PF primary elections, polling just 1 003 votes in

elections which were marred by serious voter apathy. Second best was Kambuzuma Chinjai who got 870 votes, followed by Marlver Chimutashu with 455 votes. Mathew Tichaona polled 234 votes, Enock Chigiya (215), Lancelot Koronga (135), Dorcas Bere (125), Patrick Maponga (58), Tinezvi Mahere (53) and Robert Tichareva (45).<sup>10</sup>

#### **Nomination Process**

The nomination process was conducted on the 08<sup>th</sup> of April in accordance with the Electoral Act (Chapter 2:13). The Court set in Chinhoyi and accepted nomination papers for the Zanu PF aspirant Dr. Keith Guzha and an Independent aspirant Temba Mliswa. There were no reported incidents of irregularities during the court sitting in Chinhoyi. See the table below for successful candidates and their political parties.
