- Signing of the United Nations Convention on the Rights of Persons with Disability

## What has happened in the last electoral cycle?

- Public bills on the Electoral Law
  - Driven by the Executive
- Petitions on the electoral legal framework
  - Lodged by diverse stakeholders

# Windows of Opportunity-what needs working on...?

- Advocacy on enactment of legislation and implementation of policies or actions that enhance management of democratic polls
- Advocacy for review of current legal framework in line with application of electoral cycle approach
- Promoting increased citizen participation in parliamentary processes (in line with the Parliament of Zimbabwe strategic plan)
- Enhancing leadership skills
- Media framework & engagement (sections 61 & 62 of the Constitution)

#### Windows...

- Litigation?
- Appreciation of the role and functions of parliament
- The parliamentary sitting calendar & how best to engage
- Enhancing public knowledge on how to engage parliament
- Engaging policy makers
- Synergies with relevant institutions and bodies, including parliamentary committees
- Increased public awareness of the Constitution

## Windows...

- A review of the reports of the various electoral observer missions on the previous Zimbabwean polls, up to 2018
- Progressive provisions of the Constitution on Parliament:
  - Section 119-Parliament must protect the Constitution and promote democratic governance in Zimbabwe
  - Section 141-Parliament must consult its stakeholders
- Perceptions of stakeholders on the institutions & processes related to the polls

Includes some Bills relevant to electoral issues:

- Citizenship of Zimbabwe Amendment Bill
- Zimbabwe Media Commission Bill-to open up media space
- Broadcasting Services Amendment Bill
